1. Further to reference (a), the Standing Group having now received national comments from all countries on the Berlin Contingency Plans, has forwarded their appraisal of these plans (ref. (b)) to the Military Committee in Permanent Session as provided in para. 7, reference (e). At the same time, the Standing Group has instructed me to forward a copy of reference (b) to you for information, and this I attach.

2. The Standing Group has forwarded information copies of reference (b) to Major Commanders with a request that any comments they may wish to make be made available to the Standing Group by 20 August 1962. In addition, you will note that the Standing Group has requested, per Enclosure to reference (b), the Major Commanders to make certain changes in, and provide additional data on, some aspects of their plan. You will also note from para. 3 of reference (b) that the Standing Group has suggested that this paper be discussed by the MC/PS at their meeting on 23rd August 1962 or soon thereafter. You will further note that in para. 4 of reference (b), the Standing Group recommends that information copies of reference (b) should be forwarded to Permanent Representatives of the Council through national channels.

3. You will recall that I passed to you copies of SACLANT's and SACEUR's plans under cover of SGPO 23/62 dated 8th March 1962 and SGPO 29/62 dated 30th March 1962 respectively. These are the documents referred to in references (b) and (c) in the attached MCM-94-62. We have not received a copy of the CINCHAN document referred to as reference (d) in MCM-94-62.

4. I am attaching an additional copy of reference (b) for you to pass at your discretion to Mr. Gregh with whom I have discussed the handling of this
