Item 1 OPTIONS FOR NATO MILITARY MEASURES (NR)

The Chairman reminded the Committee of SACEUR's letter of 30 June 1981(1) and said that he had suggested to the Secretary General that the matter be considered at an early meeting of Ambassadors. In the meantime, following a staff meeting, a draft memorandum setting out Military Committee views had been prepared(2). The Chairman invited the Committee to consider this draft.

Following a lengthy discussion of the draft memorandum, THE COMMITTEE AGREED that the paper, as amended by their deliberations, should be forwarded to the Secretary General(3).
