

1. In accordance with the procedures at reference, EADRCC has received today, 24 March 2017, a request for assistance. The following information was provided.

2. General Situation

Type of the Disaster : **Explosion of ammunition**

Date and Time the Disaster occurred : Ongoing

Location of the Disaster : Balaklia, Kharkiv region, Ukraine

3. Initial Assessment of the damage and description of the situation.

—A fire occurred on 23 March 2017 at 14:45 (local time) at an ammunition depot in Balaklia, Kharkiv region, Ukraine. The fire initiated the detonation of missiles and ammunition stored in the facility.

The Ukrainian authorities are undertaking all efforts to manage the consequences of the disaster:

- evacuation of the facility personnel and of local population is ongoing (up to date around 20 000 civilians were already evacuated). A 7 km danger zone was declared around the disaster area;
- all air traffic was suspended within a 40 km area around the Arsenal;
- all passenger railway traffic near the town of Balaklia was stopped;
- emergency and fire-fighting units were put on alert to prevent further spread of the fire; and

- pyrotechnical teams will be deployed to start clearing the terrain affected by the dispersion of unexploded ordonnance when conditions allow.
- 4. Ukrainian authorities have requested international assistance in the provision of protective equipment and detection devices for the Ukrainian pyrotechnic teams.
