**RE:** COMMENTS TO THE TEXT OF DR. I. PASALIC, ADDRESSED TO THE RH  
PRESIDENT DR. FRANJO TUDMAN 290398, TITLED "A DUBROVAC BANK  
CASE OR A WAR FOR SUPREMACY IN THE FEDERATION OF BIH? THE  
ROLE OF FOREIGN INTELLIGENCE SERVICES IN ORGANIZATIONS OF  
FORMER AGENTS OF KOS AND UDBE IN BIH AND RH?"

DR. I. PASALIC'S OFFICIAL LETTER ENDS WITH THE STATEMENT, " (THE ABOVE) MENTIONED IS HIGHLY ARGUMENTATIVE AND SERIOUS". DR. I. PASALIC'S LETTER CONTAINS A MIXTURE OF ACCEPTABLE AND UNACCEPTABLE " ARGUMENTS" IN THE THESIS STATING THE DESTABILIZATION OF THE RH AND THE COLLAPSE OF THE HDZ, AND "WAR FOR SUPREMACY IN THE FEDERATION OF BIH". (SINCE THEY DO NOT HAVE MUCH IN COMMON WITH ESTABLISHED FACTS; THE COLLECTION OF FACTS ON INDIVIDUALS, INCIDENTS AND SOME RELATIONS ARE SIMPLY FALSIFIED, AND IN A BEST CASE SCENARIO, INCORRECT). FOR THIS REASON, ALL THINGS CONNECTED TO THAT ARE MUCH MORE THAN "HIGHLY SERIOUS". PASALIC, WITH HIS THESES, DOES NOT INTEND TO ONLY DEFEND HIS ROLES IN THE DUBROVACKA BANK CASE (HE HAS NEVER MADE A STATEMENT) AND MANIFEST HIS AMBITIONS IN FBH, BUT HE IS OBJECTIVELY DIRECTED, NOT ONLY AGAINST I. LUCIC, BUT M. TUDMAN, AS THE HIS DIRECTOR, IN REGARDS TO THE ROLES AND TASKS ASSIGNED TO THE HIS, AND IN THE FBH REGION. PERSONALLY, I HAVE NEVER HAD, NOR DO I NOW HAVE ANY POLITICAL AMBITIONS, NOR HAVE I EVER EXPERIENCED PASALIC'S "ARGUMENTS", BUT I TAKE THEM AS A SERIOUS ATTEMPT TO OVERTHROW THE HIS, OR AT LEAST ACHIEVE HIS NEUTRALIZATION, SINCE IT IS OBVIOUS THAT FOR SOME TIME NOW, THE HIS DISTURBS THOSE INVOLVED IN CROATIAN GOVERNMENT POLITICS, FOR WHOM THE OFFICIAL POLITICS ARE ONLY A FACADE FOR FOREIGNERS, OR MERELY TACTICS, BUT THE INTENTIONS ARE IN FACT DIFFERENT. THIS IS WHY PASALIC IS PROBABLY NOT EVEN AWARE THAT HE ENGAGED HIMSELF (UNOBJECTIVELY DEFENDING HIS TOTTERED POLITICAL POSITION, SINCE HE DID NOT REALISTICALLY LOOK INTO ALL MOTIVES AND REASONS) IN SOMETHING THAT IS, IN MY OPINION, IN OPPOSITION, OR EVEN POSSIBLY NEGATES SOME FUNDAMENTAL MORALS AND PRINCIPLES UNDER WHICH BOTH THE HDZ AND CROATIAN GOVERNMENT POLITICS ARE ESTABLISHED.

#### ESTABLISHED FACTS

IN ORDER TO BETTER UNDERSTAND THE BACKGROUND AND PALASEVIC'S WRITINGS AND REMAINING EVENTS (NOT GUILTY AND GUILTY PARTICIPANTS AND THEIR INTENTIONS), IT IS NECESSARY TO CLARIFY SOME FACTS.
