

PERHAPS WE SHOULD SIT FOR A WHILE. IVICA LUCIC (BORN IN 1962) WAS NOT A MEMBER OF ANY PARTY, HOWEVER, AS OF 1990, HE WAS CHOSEN UNDER THE HDZ PARTY TO BE A REPRESENTATIVE IN THE BH PARLIAMENT, AND SUBSEQUENTLY, FOR THE FEDERATION PARLIAMENT. HE HOLDS THE RANK OF GENERAL IN THE HVO AND STAFF BRIGADIER IN THE HV. HE EARNED HIS RANK ON THE BATTLEFIELD, AND NOT IN THE OFFICE. HE ORGANIZED THE SIS IN THE HVO, IN SUCH RELATIONS WHERE AND WHEN SIS MEMBERS WERE DYING ON THE FRONT LINES (TEN OF THEM). HOWEVER, SIS MEMBERS WERE KILLING (I KNOW OF FOUR INSTANCES), AS WERE HVO MEMBERS, SINCE THEY HAD THEIR OWN OPINIONS OF HDZ AND SIS POLITICS (SOME OF THOSE PERPETRATORS ARE ON THE HAGUE LIST TODAY, WHILE OTHERS WERE AND HAVE REMAINED CRIMINALS). ZDENKO LUKIC HOLDS THE RANK OF COLONEL (IF NOT BRIGADIER) IN THE HVO, WHICH HE ACHIEVED ON THE BATTLEFIELD. HE IS ALSO PRESIDENT OF YOUNG HDZ RECRUITS. MILAN LUCIC, ALTHOUGH JUST A CONTRACTOR, AND ALTHOUGH HE SPENT MINIMAL TIME ON THE BATTLEFIELD, WAS LIGHTLY WOUNDED. THE FOURTH, YOUNGEST BROTHER DIED AT A VERY EARLY AGE IN A TRAFFIC ACCIDENT (I BELIEVE THAT HE ALSO TOOK PART IN THE WAR).

PASALIC'S INTERPRETATION:

- I. LUCIC "INTEGRATES AND CONTROLS ALL CROAT INTELLIGENCE ACTIVITIES IN BIH". I. LUKIC IS DEPUTY TO THE HIS DIRECTOR FOR CRITICAL REGIONS SINCE 1995. FOR THIS REASON HE HEADS THE HIS BRANCH OFFICE IN FBIH, WHICH HAS TEN PERSONNEL. CONTROL AND PLANNING OF INTELLIGENCE ACTIVITIES ARE EXECUTED BY THE DIRECTOR. COLLABORATION WITH OTHER INTELLIGENCE SERVICES IN FBIH - WHICH AFTER DAYTON ARE REDUCED DOWN TO THE SIS OF THE HVO, UNDER THE JURISDICTION OF I. LUKIC, AND IS REDUCED ONLY FOR THE EXCHANGE OF DOCUMENTS. THAT IS ACCORDING TO THE AGREEMENT FOR COORDINATING CROAT INTELLIGENCE SERVICES - THE SIS OF THE HVO SENDS ALL ITS INFORMATION TO THE SIS IN ZAGREB AND SUBMITS A COPY DIRECTLY TO THE HIS IN MOSTAR. THE HIS IN MOSTAR FOLLOWS UP BY SENDING EVERYTHING TO ZAGREB. THEREFORE, I.L. HAS NO AUTHORITY, NEITHER ACTUAL NOR PRACTICAL, WHICH I.P. ANNOTATES TO HIM.
- TOWARDS I. PASALIC, I. LUCIC HAS ORGANIZED THE FOLLOWING DEPENDABLE INDIVIDUALS: M. MUSIC (FORMER MEMBER OF THE UDBE) IN MOSCOW, I. BANDIC (UBDE AGENT) AT THE HAGUE, B. SARIC-K. ZUBAKOV'S CLOSEST ASSOCIATE, D. MISETIC OF THE RH EMBASSY IN SARAJEVO, G. AKRAP FOR HEAD OF OPERATIONS IN THE HIS ("CURRENTLY WORKING ON THE "DUBROVACKA BANK CASE"). " ALL THIS SPEAKS OF THE DANGEROUSLY LARGE AMOUNT OF INFLUENCE WHICH IVICA LUKIC HAS ON SERVICE JOBS". FORMALLY, THE DIRECTOR ASSISTANTS DO NOT PLACE PERSONNEL ANYWHERE (NOT EVEN IN SECRET LOCATIONS), WHICH IS THE DIRECTOR'S RESPONSIBILITY. CONCRETELY, AND FOR ALL MENTIONED INDIVIDUALS, I TAKE A GREAT DEAL OF RESPONSIBILITY SINCE I SUPPORT THEM.
