**SUBJECT: RECOMMENDED OPERATION ACTION PLAN "PUMA"**

ACTION NAME	"PUMA"
<b>REASON FOR ENACTMENT</b>	<p>DUE TO OUR OPERATIONS WORK IN THE FIELD, WE FOUND OUT THAT REPRESENTATIVES FROM THE HAGUE TRIBUNAL ARE NEGOTIATING WITH THE DIRECTOR OF THE DINARA HOTEL IN LIVNO FOR RENTING 30 ROOMS FOR THEIR INVESTIGATORS.</p> <p>ACCORDING TO OUR FINDINGS, THE HAGUE TRIBUNAL SENT THEIR INVESTIGATIVE TEAM FOR THE PURPOSE OF INVESTIGATING 210 INDIVIDUALS, OF WHICH 80 ARE FROM HERZEGOVINA, FOR WAR CRIMES.</p> <p>FURTHER, WITH OUR OPERATIONS WORK WE FOUND OUT THAT IN THE MUNICIPALITY OF LIVNO THERE ARE 17-18 MASS GRAVES WHERE INDIVIDUALS OF SERB NATIONALITY (NOT FROM THE FEDERATION) ARE BURIED, SO THAT ONE OF THE REASONS COULD BE PEOPLE THAT ARE CONNECTED OR IN ANY WAY INVOLVED IN THESE CASES.</p> <p>BECAUSE OF THE OF THE ABOVE-MENTIONED, IT IS NECESSARY TO INCLUDE THE OPERATION ACTION.</p>
<b>ACTION GOAL</b>	<p>OPERATION ACTION "PUMA" GOAL IS:</p> <ul style="list-style-type: none"> <li>- ALWAYS FOLLOWING AND OBSERVING THE HAGUE INVESTIGATIVE TEAM,</li> <li>- AS SOON AS POSSIBLE, THAT IS, BEFORE THE ARRIVAL OF THE HAGUE INVESTIGATIVE TEAM, INSPECT AND FILM/SHOOT THE EXTERIOR AND INTERIOR OF THE DINARA HOTEL IN LIVNO, AND BASED ON THE ANALYSIS OF THE COLLECTED FINDINGS AND FILM SHOT DETERMINE THE TECHNICAL EQUIPMENT FOR FOLLOWING AND OBSERVING, AND IF POSSIBLE INSTALL THE SAME BEFORE THE ARRIVAL OF THE HAGUE INVESTIGATIVE TEAM, AND TO BE MAXIMALLY ATTENTIVE AT THAT TIME,</li> <li>- FOLLOWING AND OBSERVING THE ARRIVAL AND ASSIGNMENTS OF THE HAGUE INVESTIGATIVE TEAM,</li> <li>- FOLLOWING AND OBSERVING THE RADIUS OF MOVEMENT OF THE MEMBER OF THE HAGUE INVESTIGATIVE TEAM,</li> <li>- VERIFY INFORMATION OF THE INDIVIDUALS THAT WORK AS INTERPRETERS FOR THE HAGUE INVESTIGATIVE TEAMS, AND ATTEMPT TO GET THE SAME INDIVIDUALS TO WORK WITH US.</li> </ul>
