OPERATION NAME	"GROM"
REASON FOR THE ACTION	<p>THERE IS AN OBVIOUS AND SIGNIFICANT NUMBER OF INTERNATIONAL ORGANIZATIONS ON THE BIH TERRITORY (MILITARY, POLICE AND HUMANITARIAN). AFTER FIELD OPERATIVE WORK WE FOUND OUT THAT MAJORITY OF THESE INTERNATIONAL ORGANIZATIONS BASED IN F BIH ARE PRIMARILY DOING INTELLIGENCE WORK, TO BENEFIT WORLD POLITICS AS WELL AS THEIR OWN NATIONAL INTELLIGENCE SERVICES.</p> <p>IT IS KNOWN THAT THESE INTERNATIONAL ORGANIZATIONS EMPLOY CERTAIN NUMBER OF LOCAL PEOPLE (AS TRANSLATORS, WAITING STAFF, DRIVERS, ADMINISTRATIVE STAFF, ETC.). SINCE THOSE INDIVIDUALS ARE FAMILIAR WITH THE WORK AND METHODS OF THESE INTERNATIONAL ORGANIZATIONS, NEED TO CARRY OUT OPERATION "GROM" IS NECESSARY.</p>
ACTION GOAL	<p>ACTION "GROM" GOAL IS:</p> <ul style="list-style-type: none"> - INFORMATION COLLECTION ON INDIVIDUALS, LOCAL PEOPLE EMPLOYED BY THE INTERNATIONAL ORGANIZATIONS (TRANSLATORS, WAITING STAFF, DRIVERS, ADMINISTRATIVE STAFF, ETC.), GET LIST OF INDIVIDUALS (CROATIAN NATIONALITY) - FROM THAT LIST OF CROATIAN NATIONALS, ISOLATE INDIVIDUALS WHO ARE WILLING TO COOPERATE - PAY SPECIAL ATTENTION TO THE TRANSLATORS OF THE HEADS OF THE INTERNATIONAL ORGANIZATIONS
PLAN - MEANS MEASURES AND ACTIVITIES	<p>IN ORDER TO CARRY OUT OPERATION "GROM" USE ALL ACCESSIBLE MEANS ACCORDING TO THE LAW AND SERVICE RULES AND REGULATIONS.</p> <p>THE OPERATION COORDINATOR ACCORDING TO THE NEEDS AND CAPABILITIES WILL PROVIDE USE OF SPECIAL MEANS. MEASURES AND ACTIVITIES USED, IN ORDER TO REACH THE GOAL OF THE OPERATION, SHOULD BE ACCORDING TO THE LAW AND SERVICE RULES AND REGULATIONS.
