LIKE FOR SOME OTHERS ABOUT WHICH PASALIC DOES NOT HAVE A CLUE. TRULY THEN- WHEN I MUST ADMIT THINGS ARE QUITE DIFFERENT. SCHEDULING OF THE WORKERS OF HIS WITH K.ZUBAK AND WITH VP, GOES ACCORDING TO AGREEMENT WITH PEOPLE WITH WHOM OUR WORKERS NEED TO WORK. FOR EXAMPLE, IN THE AGREEMENT WITH K ZUBAK OUR WORKER(Z.CUVALO) WAS THE HEAD OF THE CABINET FOR A YEAR - NOT TO KEEP IN CHECK ZUBAK BUT TO ORGANIZE HIS WORK AND AT THE SAME TIME FOR HIS TO HAVE FIRST HAND INFORMATION(WITH KNOWLEDGE AND HELP OF K. ZUBAK).IN THE SAME FASHION WORKS WITH ZUBAK B.SARIC, AND AS HIGH ENVOY OF RH D. MISETIC .I BANDIC WAS SENT TO HAAG NOT BECAUSE OF I. LUCIC, BUT BECAUSE HE WORKED FOR HIS(CROATIAN INTELLIGENCE SERVICE) IN SARAJEVO (AS HIGH ENVOY FOR RH) WITH THE DUTY OF PAYING FOR WORK OF MUSLIM INTELLIGENCE SERVICE TIED TO HAAG. HE WAS SENT TO HAAG TO OBSERVE THE ACTIVITIES, PRIMARILY OF MUSLIMS WHO HAD EXCEPTIONALLY STRONG TIE IN HAAG. I. BANDIC WORKED IN SARAJEVO UNDER MOST DIFFICULT CONDITIONS AT THE TIME OF SIEGE OF SARAJEVO, AND SEVERAL TIMES THE VEHICLES IN WHICH HE EXITED WERE HIT. IF ANYONE HAS PROVEN HIS BELONGING AND LOYALTY, IT IS HE I .BANDIC. IT IS A FACT THAT HE WORKED FOR SDB SINCE 1987. THE FACT IS, THAT HE FOUGHT IN HERZEGOVINA FROM THE START IN 1992. .FACT IS THAT I BANDIC DID NOT CAUSE PROBLEMS AT THE TIME OF WAR IN HERZEGOVINA, NEITHER DURING HIS WORK IN SARAJEVO. BUT, THERE ARE THE REPORTS OF HIS FROM HAAG WHICH POINT TO SOME MEN WHO COMPROMISED OUR POSITIONS TOWARD OFFICIAL HAAG. M MUSIC HAS THE SAME BIOGRAPHY AS THAT OF I BANDIC ,BUT HIS PRESENCE IN MOSCOW DOES NOT TIE RUSSIAN MAFIA WITH BARAC (TO WHAT ALLUDES PASALIC)BUT IT UNCOVERS THAT OUR, CROATIAN ,TIES IN FINDING SUPPLY OF ARMS ,WERE NOT SO SECRET AS WAS CLAIMED. G.AKRAP CAME TO HIS FROM HDZ AND HE IS ONE OF BEST WORKERS OF HIS. I. LUCIC WAS NOT IN PROXIMITY WHEN THERE WAS TALK ABOUT HIS PLACEMENT. G. AKRAP WAS NOT DIRECTLY GIVEN WORK WITH (DB) THE BANK OF DUBROVNIK. BUT THE WORK IS COORDINATED BY THE MANAGER OF HIS AND DIRECTLY THAT IS DONE BY THE PEOPLE FROM THE BRENCH FOR ORGANIZED CRIME(N. CURIC, D. KUZINA).G. AKRAP IS A PROBLEM SINCE (BY START BY AKRAP AND WITH ASSISTANCE BY LUCIC, THE TWO MONTHS BEFORE(PRIOR TO THE MEETING OF HDZ) HAD TRIED DISCREDITING OF A.BAKOVIC AND M KAPULICA". THIS KIND OF CONCLUSIONS WANT TO SHOW THAT IN HIS EXISTS CONSPIRACY OF SOME PEOPLE WHO ARE PLAYING THEIR GAME.
