BASED ON THE ACTIVITIES BY A LARGE NUMBER OF INTERNATIONAL ORGANIZATIONS IN THE TERRITORY OF BiH WHOSE OPERATIONS IN SPECIFIC OCCURRENCES HAD A NEGATIVE IMPACT ON THE SECURITY SITUATION IN THE TERRITORY OF BiH. WITH THE AIM OF PREVENTING ACTIVITIES THAT WOULD HAVE A NEGATIVE EFFECT ON THE SECURITY SITUATION IN THE TERRITORY, I PRESENT YOU A:

**DECISION
ON ESTABLISHING AN OPERATIVE ACTION**

1. FOR CARRYING OUT ALL TASKS OF THE OPERATIVE ACTION, IT MUST BE PLANNED AND USE ALL AVAILABLE MEANS. THE MEASURE AND ACTIVITIES ARE TO BE IN CONGRUENCE WITH LAWS AND THE SNS BOOK OF RULES FOR WORK.
2. FOR ACHIEVING THE GOAL OF THE OPERATIVE ACTION, WE MUST HAVE CONTINUAL OBSERVATION AND RECORD ACTIVITIES, MEASURES, AIMS AND WAYS WORK IS ORDERED BY THE INTERNATIONAL ORGANIZATIONS WHO COULD EFFECT THE SECURITY SITUATION IN THE TERRITORY OF BiH.
3. THE CHIEF OF THE OPERATIONS SECTOR IS RESPONSIBLE FOR FORMING THE PLAN FOR THE OPERATIVE ACTION AND ALSO RESPONSIBLE FOR CARRYING OUT THE TASKS BY THE OPERATIVE ACTION.
4. THE TIME LIMIT FOR EXECUTING THE PLAN OF THE OPERATIVE ACTION WILL BE SEPT. 23, 1999 AND WILL BE DELIVERED FOR APPROVAL ON THE MENTIONED DATE UNTIL 10:00.
5. DUE TO THE NATURE OF THE OPERATION, I NEED TO BE INFORMED ON A REGULAR BASIS REGARDING THE COURSE OF THE ACTIONS AS WELL AS WHAT HAS BEEN DONE ACCORDING TO THE PLAN.
