SUBJECT: PLAN PROPOSAL FOR THE OPERATIVE ACTION "PANTHER"

NAME OF ACTION: "PANTHER"

REASON FOR ACTION: IT IS EVIDENT THAT THERE IS A LARGE NUMBER OF INTERNATIONAL ORGANIZATIONS PRESENT IN THE TERRITORY OF F BiH.

WITH THE OPERATIVE WORK IN THE FIELD, WE HAVE FOUND OUT THAT A NUMBER OF MEMBERS IN INTERNATIONAL ORGANIZATIONS STATIONED IN THE TERRITORY OF F BiH, ARE DOING INTELLIGENCE WORK TO BE USED IN INTERNATIONAL POLITICS AND USED IN THE INTERESTS OF THEIR HOME COUNTRIES NATIONAL SECURITY SERVICES.

IT IS ALSO KNOWN THAT SOME MEMBERS OF INTERNATIONAL ORGANIZATIONS ARE ACTIVE IN CRIMINAL ACTIVITIES IN THE TERRITORY OF BiH AND IN SOME CASES ARE THE LONE ORGANIZERS OF CRIMINAL ACTIVITIES.

RECENTLY, THERE HAS BEEN MORE FREQUENT EVIDENCE OF OPERATIVE ACTIONS BEING CARRIED OUT BY INTERNATIONAL ORGANIZATIONS. IT IS AIMED IN CROAT AREAS WITH THE GOAL OF DESTABILIZING THE POLITICS THAT IS HEADING THE CROAT POPULACE IN BiH. THAT ALONE THROWS TRANSGRESSION OF CONFLICT BETWEEN THE MUSLIMS AND CROATS IN THE TERRITORY OF BiH. IT COULD BRING AN INFERIOR SITUATION IN RELATION ON THE SERBS AND BOSNIAKS. THIS WOULD HELP THE BOSNIAC LEADERSHIP AND MANY ARAB COUNTRIES TO CARRY OUT A DEFINITE PRESSURE ON THE INTERNATIONAL ORGANIZATIONS WITH THE AIM OF PUTTING THE BOSNIAC POPULACE IN CONTROL OF THE CROATS. THAT ALONE WILL MAKE IT POSSIBLE FOR THEM TO TAKE SPECIFIC STRATEGIC TERRITORIAL POINTS FOR MAKING BOSNIAC IDEOLOGY AN ACTUALIZATION (GATE TO THE SEA AND ESTABLISHING A MUSLIM STATE) IF A LARGE AMOUNT OF CROATS MOVE OUT FROM THAT TERRITORY.

DUE TO THE ABOVE-MENTIONED, WE ARE ESTABLISHING THE OPERATIVE ACTION "PANTHER"

ACTION GOAL - THE AIMS OF THE OPERATIVE ACTION "PANTHER" ARE:

- EXAMINE THE SITUATION IN THE FIELD AS CLOSE AS POSSIBLE BY GETTING THE STARTING PARAMETERS ESTIMATES BY THE GLOBAL POLITICS IN THE INTERNATIONAL ORGANIZATIONS TOWARD THE TERRITORY OF BiH.
- UNCOVER THE ROLES OF ALL INTERNATIONAL ORGANIZATIONS AND THEIR CONTRIBUTION ON PUTTING PRESSURE ON CROATS IN THE TERRITORY OF BiH.
- OBSERVING AND ANALYZING ALL OPERATIVE ACTIONS CARRIED OUT BY INTERNATIONAL ORGANIZATIONS TOWARDS CROATS IN THE TERRITORY OF BiH.
- SPECIAL ATTENTION OBSERVING INTERNATIONAL ORGANIZATIONS WHO WORK WITH EMBASSIES FROM ISLAMIC COUNTRIES.
- CONFIRM AND OBSERVE SPECIFIC MEMBERS OF INTERNATIONAL ORGANIZATIONS.

PLAN MEANS, MEASURES AND ACTIVITIES - TO CARRY OUT THE OPERATIVE ACTION "PANTHER", USE ALL LEGAL ACCESSIBLE MEANS NECESSARY IN CONGRUENCE WITH THE BOOK OF WORK REGULATIONS.

THE USE OF SPECIAL MEANS WOULD BE CONSIDERED IF NEEDED AND IN RELATION TO THE POSSIBILITIES THROUGH THE OPERATION COORDINATOR.

THE MEASURES AND ACTIVITIES THAT ARE TAKEN IN THE DIRECTION OF ACHIEVING THE AIM OF THE ACTION HAVE TO BE IN CONGRUENCE WITH THE LAWS AND OFFICIAL BOOK OF WORK REGULATIONS. THEY ALSO HAVE TO BE DIRECTED AT:
