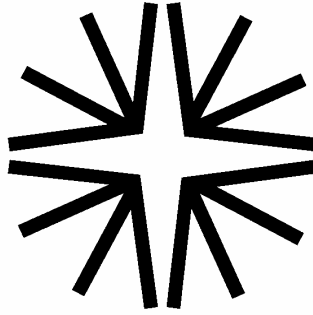

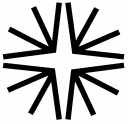
1. Situation update:

1.1 Recovery and response operations continue in the areas affected by Hurricane Katrina. Little Rock AFB in Arkansas is the primary airport being used for international donor flights. The second dedicated NATO flight carrying Austrian and Slovakian donations is scheduled for 15 September 05 to move cargo from Ramstein AB to Little Rock AFB. There is also a third dedicated NATO cargo flight scheduled for 16 September 05. The Austrian donations have been moved by truck to Ramstein AB on 13 September and another truck bringing donations from Slovak Republic is scheduled to arrive in Ramstein AB today, 14 September 05. A truck carrying donations from Finland will leave for Germany today with a scheduled arrival at the Ramstein AB 16 September 05. Also movement of donations from Czech Republic and Norway are to take place on 15 September 05.

1.2 On Saturday, 10 September 2005, the US Government (USG) accepted some of the offers of assistance by Czech Republic, Denmark, Luxembourg, Norway, Romania, Slovak Republic and Slovenia; on Monday, 12 September 2005, also offers from Austria and Finland were accepted. Austria, Czech Republic, Denmark, Finland, Slovak Republic and Slovenia indicated that they would use the NATO-offered movement system.

1.3 Also Bulgaria, Lithuania and Turkey informed the EADRCC that, depending on the validation of their offers, they opt to utilise NATO-offered lift capabilities.

1.4 In light of this and with reference to the North Atlantic Council's (NAC's) decision on 9 September to offer NATO lift assets to transport requested items from Allied and Partner nations to the United States, EAPC nations are invited to utilise this Alliance capability in order to expeditiously move the requested assistance to the United States.

1.5 SHAPE Allied Movement Coordination Centre (AMCC) has designated Ramstein Airbase, Germany as the European hub for the NATO air-bridge. Nations may be requested by the EADRCC, on a case by case basis, to transport their accepted donations to the Ramstein AB for onward movement.

**1.6 US authorities have informed EADRCC that they wish to have relief items donated by Allies and Partners to be delivered through the NATO air-bridge by 23 September 05 to Little Rock, Arkansas.**

1.7 Interested nations should immediately contact the Euro-Atlantic Disaster Response Co-ordination Centre (EADRCC) in order to request NATO airlift coordination. Nations who offered their assistance are requested to inform whether they will put their aid through the NATO-offered movement system.

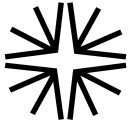
1.8 If yes, nations are kindly requested to provide the following essential planning data by e-mail to the EADRCC:

- a. Nature of the item(s) to be shipped, e.g. tents, pumps, blankets etc...
- b. Weight in kilograms
- c. Volume in metric
- d. Dimensions in metric
- e. Type of packaging e.g. bales, rolls, boxes, etc
- f. Whether palletised or not. If palletised, specify the type of pallet(s) e.g. Europallets or...etc
- g. If dangerous good e.g. HAZMAT etc
- h. Where ( location ) available for pick up and when ( Specify The Date/Time/Group i.e. DTG) in GMT
- i. Is the shipper is willing to move the items to be shipped to the designated point of loading?
- j. Specify any other special instructions
- k. Specify a telephone Point of Contact (POC), and if possible an alternative POC and the name of the person completing this questionnaire.

NOTE: It is important for that each one of the 11 lines of the above questionnaire be completed. Please indicate NO if the answer is negative.

1.9 The first NATO cargo flight, which departed from the Czech Republic on 11 September 2005 with 390 camp beds and 14 large tents, arrived in Little Rock AFB, Arkansas on 12 September 2005 at 2030 UTC.

2. The US authorities greatly appreciate the support provided by the EAPC countries in the aftermath of Hurricane Katrina. However, the US authorities are now sufficiently



advanced in their efforts to feed hurricane victims and they have confirmed that **no additional Meals Ready to Eat (MREs)** are required. In addition, there is no further need for foreign personnel support.

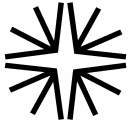

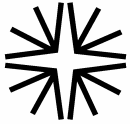

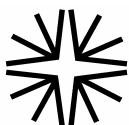
