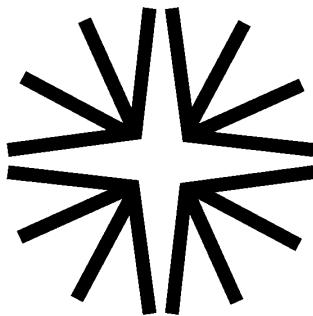

1. In accordance with the procedures at reference, the EADRCC received a request for international assistance from Ukraine on Thursday 25 June 2020. The following information was provided.

2. General situation

Type of the disaster : Floods
Date and time the disaster occurred : 25 June 2020
Location of the disaster : Western Ukraine, in the Ivano-Frankivsk and Chernivtsi regions

3. Update of the situation

3.1. Huge floods in Western Ukraine have caused significant damage to critical infrastructure. The situation threatens the lives of the citizens of Ukraine, adversely affects economic activity and poses a threat to the sustainability of the public administration. Thus far, the floods destroyed 110 km of road infrastructure and 90 bridges.

3.2. On 1 August 2020, **Ukraine** informed the EADRCC of the closure of its request for international assistance for the floods in Western Ukraine.

4. **Additional Assistance provided through EADRCC:**

- 4.1. On 7 July 2020, the UK provided £100,000 to support the International Federation of Red Cross and Red Crescent Societies (IFRC) in their response to the floods in Ukraine. This support will also address COVID-19 risks on a population that has already been badly affected by the pandemic. The short term response will include:
 - 4.2. Provision of hygiene kits
 - 4.3. Hygiene promotion
 - 4.4. Provision of products (blankets, bed linen, etc.)
 - 4.5. Provision of food kits,
 - 4.6. Water and sanitation activity
 - 4.7. UK funding will also be extended to medium-term recovery but will coordinate activity based on a donor needs assessment. The IFRC is coordinating its efforts with the Government of Ukraine and is in direct communication with the State Emergency Service, President's Office, Prime Minister's Office, Ministries.
 - 4.8. On 15 July 2020, **Canada** informed the EADRCC that it has made a contribution of CAD \$30,000 in response to floods in Ukraine through an ongoing project with the Canadian Red Cross Society Emergency Disaster Assistance Fund (EDAF) to the IFRC in support of the Ukrainian Red Cross Society emergency operation.
