1. As a result of the destruction of the dam of the Kakhovka hydroelectric power plant (KHPP), and in accordance with the procedures at reference, the EADRCC has received an urgent request for international humanitarian assistance from Ukraine to protect its population against the flooding's and its impact.

2. **Description**

- 2.1 The Ukrhydroenergo reports that KHPP was completely destroyed as a result of an explosion in the engine room. The station cannot be restored.
- 2.2 Blowing up the Kakhovska HPP will have devastating consequences, including regional flooding, long-term water shortages, irreparable damages to thousands of innocent civilians, and the ecosystem.
- 2.3 As of 07:30 on 6 June, the settlements of Tyahynka, Lvov, Odradokamyanka in the Beryslav district, Ivanivka, Mykilske Tokarivka, Poniativka, Bilozerka, and the Ostrov district of Kherson are completely or partially flooded.
- 2.4 The explosion of Kakhovka HPP may have negative consequences for Zaporizhzhia Nuclear Power Plant (ZNPP). Water from the Kakhovka Reservoir is necessary for the plant to receive water for turbine condensers and ZNPP safety systems. Currently, the station's cooling pond is full. As of 8:00 a.m. on 6 June, the water level was 16.6 meters, which is enough for the needs of the station, as reported by Energoatom. The situation at ZNPP is currently under control and Ukrainian personnel are monitoring it.
- 2.5 Ukrainian authorities are evacuating residents of the flooded areas and assessing the environmental impact and the threat to the Zaporizhzhia Nuclear Power Plant. However, due to the lack of access, conducting such an assessment is difficult.
- 2.6 The Mission of Ukraine to NATO has provided its most urgent needs, in line with the current situation following the destruction of the dam of the Kakhovka hydroelectric power plant.
