'Who contributes to alliances and why ? Is a state's aggregate relative capabilities the major factor in determining participation ? How do perceived threats, dependence on other alliance members, domestic politics, and learned experience from analogous situations matter ? For the most part, questions like these have been answered by using NATO as the example. Being the most well-known and long-standing alliance in contemporary history, NATO has always been regarded as the standard. While this is understandable, given NATO's role during the Cold War period, this reliance on NATO as a model has resulted in a gap in our understanding of burden sharing more generally. Alliances will be looser and more ad hoc in the post-Cold War international system than they were between 1947 and 1991. The authors recognize this situation and the key policy issues it raises with regard to multilateral conflict management. The assembled authors study alliances in a more general sense, using the coalition that was established to deal with the Gulf War as their example. Looking individually at all of the countries that took part in the coalition, the authors provide a richly detailed study of alliances and the way they work now.'

'This study applies an experimental interdisciplinary methodology for understanding the possible reasoning of opponents in crisis and conflict and for using that understanding to develop well-hedged and adaptive deterrent strategies. First, the authors develop alternative models of Saddam Hussein's reasoning over the period of February 1990 to February 1991, using only information available during the crisis rather than exploiting the benefits of hindsight. Then, the authors explain Saddam's behavior retrospectively and argue that having developed and worked with the alternative models during the crisis could have materially improved the formulation of US

strategy. Without the Iraqi's mistakes to provide openings, however, the outcome would have been far different in spite of the Coalition's technology, and Coalition casualties would likely have reached or exceeded prewar expectations. But without the new weapons, mistakes like the Iraqis' would not have enabled the Coalition to prevail with the historically low losses of the Gulf War. Many previous armies have displayed combat skills no better than Iraq's, but without producing results anything like those of 1991; only a powerful interaction between skill imbalance and new technology can explain the difference.

In their statements in the Gulf, the Iraqi president was made the ultimate enemy, dangerous and evil, who had to be crushed in order to make the world safe again. As to Bosnia, the evanescent enemies left the Western powers bewildered and unwilling to dictate any solutions. Besides framing the conflicts as heroic battles or tragic feuds, the Western leaders employed various metaphors to make the distant events and their policies seem significant and coherent. The apparently harmless and light-hearted comparisons with children's stories, card games, business deals, and sports competitions induced forceful action in the Gulf; by contrast, paralleling the situation with sad dramas, horrible nightmares, violent natural catastrophes, and treacherous morasses made decisive interference impossible in Bosnia. The Gulf metaphors made clear to all the folly of leaving the princess in the lurch, not playing a winning hand, passing up the chance for a great investment, or canceling the Cup Final. In Bosnia, the metaphors made it unthinkable to dash onto the stage to defend the scapegoat, act on the visions of a frightening drama, stand in the way of the whirlwind, or try to cross the quicksand.
